



INFORMATION ON THE PROCESSING OF PERSONAL DATA OF USERS CONSULTING THE WEBSITE OF ABE ELETTRONICA

Dear User,

In compliance with the Regulation on the protection of natural persons with regard to the processing of personal data and the free movement of such data (EU Regulation 2016/679 – GDPR), we wish to inform you that ABE Elettronica S.r.l. (hereinafter also referred to as "ABE") processes your personal data for the purpose of sending newsletters, as outlined below, in accordance with the current legislation on personal data protection.

Data Controller

Types of Data Processed

Browsing Data

This category of data includes the IP addresses or domain names of the computers and terminals used by users, the addresses in URI/URL (Uniform Resource Identifier/Locator) notation of the resources requested, the time of the request, the method used in submitting the request to the server, the size of the file obtained in response, the numerical code indicating the status of the response given by the server (successful, error, etc.) and other parameters relating to the user's operating system and computer environment.

These data, necessary for the use of web services, are also processed for the purpose of:

- obtain statistical information on the use of the services (most visited pages, number of visitors by time slot or daily, geographical areas of origin, etc.)
- check the proper functioning of the services offered

Data voluntarily provided by the user

Contact data, such as first name, last name, telephone number, e-mail address and any other personal data entered in the "NETWORK PLANNING", "PRODUCT REGISTRATION", "DOWNLOAD" and forms on the "SERVICES", "DOWNLOAD" pages of this site should be considered.

Purpose of Processing

ABE processes the personal data provided to respond to requests received through the "NETWORK PLANNING", "PRODUCT REGISTRATION", "DOWNLOAD" and forms on the "SERVICES", "DOWNLOAD" and pages of this site.

Legal Basis for Processing

The legal basis for processing is the explicit consent of the data subject, as provided for by Article 6(1)(a) of the GDPR.

Nature of data provision

The optional, explicit and voluntary sending of personal data by you, implies the subsequent acquisition of your data, necessary for the provision of the requested services.

Place of data processing

The processing operations related to the web services of this site take place at the aforementioned headquarters of the Data Controller and are handled only by personnel expressly authorized by the Data Controller, or by any third-party providers in charge of occasional maintenance operations, appointed as Data Processors pursuant to Article 28 of the GDPR.





Processing Methods

Your personal data may be processed in paper format and with the aid of electronic tools, with the observance of all appropriate measures to ensure the security and confidentiality of the same, with access allowed only to authorized operators, previously appointed Authorized, or by individuals appointed as Data Processors who perform outsourced services on behalf of ABE. Access to the data is allowed to authorized individuals only for the time strictly necessary to process them and exclusively for the purposes indicated. In addition, they will be processed by adopting appropriate security measures to minimize the risks of destruction or loss, even accidental, of the data themselves, of unauthorized access or processing that is not permitted or does not conform to the indicated collection purposes.

Data sharing, communication and dissemination

The data collected may be transferred or communicated to other companies for activities strictly related and instrumental to the operation of the service, such as the management of the IT system. The personal data provided by users who forward requests for the sending of informative material (brochures, informational material, etc.) are used for the sole purpose of performing the service or provision requested and are communicated to third parties only if this is necessary for that purpose. Outside of these cases, personal data will not be communicated unless provided for by contract or law, or unless specific consent is requested from the data subject.

In this sense, personal data could be transmitted to third parties, but only and exclusively in the event that:

- there is a need to share information with third parties in order to provide the requested service
- this is necessary in order to comply with requests from the Judicial or Public Security Authorities.

No data from the web service is disseminated.

Retention Period

Your contact data will be processed and stored in a form that allows their identification for a period not exceeding 1 (one) year, starting from the date of expression of your consent.

Browsing data will not persist for more than 10 (ten) days (except for possible needs of investigation of crimes by the judicial authority).

Transfer of Data Abroad

The Data Controller does not transfer personal data outside the European Union.

Rights of the Data Subject

Pursuant to Articles 15 et seq. of the GDPR, we inform you that, in the cases provided for, you may exercise the following rights:

- Right of access (Article 15 GDPR): The right to obtain confirmation as to whether personal data concerning you are being processed and to access those data;
- Right to rectification (Article 16 GDPR): The right to request the correction of inaccurate or incomplete data;
- Right to erasure (right to be forgotten) (Article 17 GDPR): The right to request the deletion of personal data when they are no longer necessary for the purposes for which they were collected:
- Right to restriction of processing (Article 18 GDPR): The right to request the limitation of data processing under certain conditions;
- Right to data portability (Article 20 GDPR): The right to receive your personal data in a structured, commonly used, and machine-readable format and to request their transmission to another Data Controller, if technically feasible.





Additionally, pursuant to Article 7(3) of the Regulation, you have the right to withdraw consent at any time, without affecting the lawfulness of processing based on consent before its withdrawal.

Right to Lodge a Complaint

If you believe that the processing of your personal data violates the Regulation, you have the right to lodge a complaint with the Supervisory Authority, following the procedures and instructions published on the official website of the Authority (www.garanteprivacy.it), as provided for by Article 77 of the Regulation, or to take legal action (Article 79 GDPR).

How to Exercise Your Rights

The exercise of rights is not subject to any formal constraints and is free of charge.

Cookies

No personal data of users is purposely acquired by the site.

No use is made of cookies for the transmission of information of a personal nature, nor are so-called persistent cookies of any kind, i.e. systems for tracking users, used.

The use of c.d. session cookies (which are not stored persistently on the user's computer and disappear when the browser is closed) is strictly limited to the transmission of session identifiers (consisting of random numbers generated by the server) necessary to enable the safe and efficient exploration of the site.

The so-called session cookies used in this site avoid the use of other computer techniques potentially prejudicial to the privacy of users' browsing and do not allow the acquisition of personal identification data of the user.

Profiling cookies

This site does not use profiling cookies to send you advertisements in line with your preferences. This site uses only technical cookies, to save the User's session and to perform other activities strictly necessary for the operation of this Website, such as in relation to traffic distribution.

This site uses:

- Technical cookies necessary for navigation by the User, without these cookies, the Website may not function properly.
- Technical cookies that facilitates the user's navigation, recognizing it and avoiding that the short cookie information contained in the banner reappears in the case of links to the site made within the deadline.
